# SURS

If you are planning on retiring from Oakton after September 1, 2024, how SURS will calculate your service is changing - for the better. SURS has published an easy-to-read summary of these changes. In short, these changes are a result of Public Act 103-0548 that was signed into law in August of 2023, amending "the SURS Article of the Illinois Pension Code to change the method in which service credit is granted and eliminate the part-time adjustment for participants of SURS on or after September 1, 2024." The new law lowers the requirement from 15 days to one day per month on or after September 1, 2024, granting one month of service credit for each month in which adjuncts are paid and make contributions to SURS. This is a huge win for adjuncts! A session on SURS will also be presented by the AFA during Orientation Week.

# Mandatory On-line Trainings Due

The due date is November 30 for two mandatory trainings the Mandated Reporter for Child Abuse and Neglect training and Sexual Harassment Prevention refresher training. Together they take about an hour and a half. They are provided by Vector Solutions, which will keep your training record and evidence of completion. You can also download a certificate for your records. *Do not* send the certificates to HR or CPD; they have it already. The emails that you are receiving will stop when you finish the training. You *do* need to send to HR in DP 1260 the <u>"CANTS 22 Acknowledgement of Mandated Reporter Status" form</u>, either by email (<u>hr@oakton.edu</u>) or by sending a paper copy. HR will keep this in your personnel file.

#### I Know Where You Live....

Have you taken a class at Oakton? Many of us have and not realized that the profile information that we may have entered on D2L is visible to everyone registered in a class. If you have entered any personal information – such as your address – it is accessible to everyone in that class even though consent has not been asked of either you or of any of the students. # Teaching Developmental Math or English?

OCCFA president Suzie Ziegenhorn shared an email with all of us about the Developmental Education Reform At (110 ILCS 175) requiring "that all community colleges consider multiple measures for determining a student's placement in introductory English and mathematics courses." For the full text of the proposed amendment, see pages 14649-50 of the Oct. 20, 2023 Illinois Register of Public Agencies.
